The Council agreed that NSC should be advised that the time had passed and that there was still no action on site and therefore request that enforcement should be taken.

# Traffic Issues & Footpaths

Kamala is still conversing with Bristol University regarding air quality monitoring. Simon has reported a number of minor issues, which will be addressed by NSC. This includes relocating a couple of road signs, making the Denny View 75-yard sign more prominent, modifying the surface of the cycle path near Leigh Bank, and installing some flexible bollards along the path.

There is currently a consultation regarding the extension of double yellow lines up Manor Road that the Parish Council have asked for. The painted "SLOW" sign also needs refreshing; this has been promised, but action is still pending.

Regarding Clifton Bridge, there is a proposed toll increase from £1 to £1.50 starting in January 2026, with further annual increases proposed due to expected traffic reductions in the coming years. The consultation for this proposal closes on 7th November 2025.

#### Verges

David Smith will be asked to flail the verges to Manor Road, Manor Lane, A369 between Home Farm Road and the Avenue and the east verge of the A 369 from Harris Lane towards the George. STP to instruct David Smith. Community pay back team has cleared the footway between Church Road and Home Farm Road and will be asked to clean the graffiti and clean away more verges at Poundbatch Farm layby.

# Playing Fields & Events

The Civic Society is considering engaging a third-party professional to manage the fireworks, while the Civic Society will continue to manage the

remainder of the event, including the bonfire, for the annual gathering in the Old School Field. This year, the Civic Society will be using a different field. ALPC and the Civic Society will need to run the event as a joint venture, so that it is covered under ALPC's insurance. Action: STP and MW to check insurance coverage.
