Local Plan – The final consultation period will run for four weeks and closes on 12th December. All previously submitted comments will be disregarded, and only the new responses will be considered and fed directly into the planning process. There is some uncertainty around what is meant by assessing whether the Local Plan is "sound." In theory, all aspects of the plan are open for consultation. There also appears to be a lack of a supplementary planning document, which could contain points we might wish to challenge. It has been suggested that a working group be formed, possibly in collaboration with Pill and Easton-in-Gordano Parish Council. In addition, we may wish to consider holding a public meeting with Abbots Leigh residents, potentially on 3rd December at the village hall. JHM reported that she and STP had attended a meeting with Waddeton Park the promoters of the scheme on Alvis land opposite St Katherines together with representatives of Pill & EiG Parish Council, to hear about their proposals for the site for which they intend submitting a planning application soon. They were advised that we considered that they should wait until the local plan has been approved with the specific supplementary local planning document.

Ward Councillor Report (Pill Ward) from Councillor Jenna Ho Marris.

Library Consultation - The library consultation closed on 24 October and officers are reviewing the approximately 4,500 replies that were received across the district. STP and JHM joined several meetings of the Friends of Pill Library group who are trying to increase footfall and ultimately hold events and raise money to support the library. Their aim is to keep the library open but they do not wish to take on the community managed model that NSC is trying to encourage due to concerns about volunteer capacity and sustainability. Pill Parish Council are also reluctant to endorse a community managed model. Abbots Leigh Parish Council have offered to contribute to the costs of running the library. During the discussions we have also suggested a transfer of the leaseholder from NSC to a Pill based non-

profit, so that the library would be eligible for business rates relief saving some £2,500 per year. JHM is aware of the cost pressures on NSC but it does not seem fair that the libraries in the most socio-economically deprived and geographically isolated parts of the district have to close, with only 30 mins earlier closing times for the towns. JHM has meetings the following week with officers together with the councillor for Winscombe, and also with our MP Sadik to explore options.

It is hoped that the Community Payback initiative will be shared with Pill and Easton-in-Gordano Parish Council. STP has been in touch with Cllr. Bob Buck from PEIG PC regarding this.
